

Stubbings Infant School and Central Street Infant and Nursery School are joined together with Riverside Junior School in a Federation. This means that they share school leadership and a single Governing Body.

Governors are responsible for the quality of education our children receive in all three schools. The governance role is to set the long term strategic direction and vision for the Federation, to appoint school leaders who will manage the schools and then to keep regular oversight of what is happening in our schools. We do this by visiting school and having regular meetings with school leaders.

Our Governors come from the local community, from parents and from staff. We have a Code of Conduct that describes what we expect from individual Governors. The structure of the governing body is set out in the Instrument of Governance and this is reviewed regularly to make sure that the structure works for our Federation. The current chair of the full governing body is Amanda Ward.

The Governors meet at least 5 times each year to discuss the strategic direction of the school. There are 2 sub committees which conduct most of the business:

- The Curriculum and Standards Committee which looks at the standards, progress and care of the children. The Chair of this committee is Ian Davies.
- The Finance, Staffing and Pay Committee is responsible for budget, buildings and staffing issues. The Chair of this committee is Giles Dring.

These 2 committees report to all Governors at the Full Governors meetings. We have Terms of Reference that set out our approach to governance across the main board and our two sub committees.

Being a governor is a hugely important and rewarding role. Governors bring a wide range of diverse skills and experiences to the board and have been carefully matched to the needs of each school. From time to time we have vacancies and then look to match interested people to the current skills gaps that we have. Is this something which could interest you?
